

SMALL TREASURES: Art for H2O fund raiser

For the November Gallery Show which is open to everyone, non-members and all members, OSA is calling for artists to create four small works of art in any one theme, chosen by the artist. This is an opportunity to push creative boundaries by working with an unfamiliar medium or challenging subject. By participating in this unjuried event you will also be supporting OSA's efforts to bring water to the downstairs classroom. Timed for holiday shopping, this show is expected to attract many visitors who can expect to find art by local talent, both emerging and well known artists, at reasonable prices.

MEDIUM

All four pieces must be the same medium. Oil, Acrylic, Watercolor, Collage, Mixed Media, Fiber, Metal, Wire, Clay, Glass and Photography are accepted mediums. Works may be 3-dimensional and may extend from panel surface up to 2 inches and small parts may extend up to one inch beyond the 6-inch perimeter as long as at least 90 percent of the 6-inch perimeter is maintained. Canvas, watercolor paper, etc. may be attached to the surface. Please keep weight to 6 ounces per square (boards are 3 oz).

THEME

Be creative with your theme — it will help tie your pieces together. A few examples: Item (bike), Color (green), Boats, Animal, Word (love), Landmark (bridges), Place (Cannon Beach), Abstracts

PRICING

Artist will set the same sale price for each individual piece — we suggest between \$20 and \$80. While no commission will be taken, donations to OSA are encouraged. Artwork will remain with the exhibit until the close of the show.

HANGING

All four pieces will hang together vertically. All pieces must be signed, titled and priced on the back. No framing please.

TO ENTER

1. Submit application, available at the OSA Gallery desk or www.OregonSocietyofArtists.com along with a non-refundable entry fee of \$20 (\$16 for subsequent entries).
2. OSA will provide each entry with four 6"x6" Aquabord or Claybord flat panels by Ampersand which must be used as a base for artwork.
3. The challenge is to complete all four. If you do not complete four, bring in what you have completed.
4. Artwork must be original. No wet paintings!

Application entry time has been extended.

Please hand deliver or mail application to OSA. Art panels may be picked up when application is submitted.
